SYLLABUS

The course aims to describe the evolution of the capitalist system from 1500 to 1989. Emphasis is placed on the development of the system in Europe both during the period of commercial capitalism, but mainly on the conditions of genesis and spread of the so-called "industrial revolution".

Important themes that are analyzed, are mentioned below:

- The exodus of Europeans and social conditions in 16th century Europe.
- The institutional changes in Europe that contributed to the emergence of commercial capitalism
- The organization of international trade and the great colonial empires.
- The problem of the transition to capitalism.
- The conditions of change in the mode of production in 18th century England.
- The spread of the industrial revolution in Europe after 1800.
- Social changes in 19th century Europe.
- The "second industrial revolution": New forms of organization of production.
- Global economic expansion before 1914.
- Economic fluctuations and the crisis of 1929.
- Social and political changes in interwar Europe.
- The Bretton-Woods system, the Cold War, the ECSC, the EEC, and the EU
- Why did some countries become rich, and others remain poor?
